Introduction

Sharing your personal data

Birketts LLP will share applicant data internally – our HR department and the hiring manager(s) will be provided with your application data. Birketts LLP will not share your data externally unless required to do so for legal purposes. Your personal data will not be shared outside of the European Economic Area (EEA) unless Standard Contractual Clauses (SCC's) are in place.

How long will we retain your data?

We will retain your application data for 3 years from the date you provided it to us, although it may be traceable in email for up to 20 years. How do we protect your personal data? Birketts LLP use a wide range of security techniques in order to protect your personal data, these controls include:
